What is the overall deductible ?	No deductible Out-of-network provider /services: \$5,000 individual/\$10,000 family	See the upcoming pages for your costs for services this plan covers.
Are there services covered before you meet your deductible ?	No	This plan covers some items and services even if you haven't yet met the deductible amount. But a copayment or coinsurance may apply. For example, this plan covers certain preventive services without cost-sharing and before you meet your deductible . See a list of covered preventive services at https://www.healthcare.gov/coverage/preventive-care-benefits/
Are there other deductibles for specific services?	No	You don't have to meet deductibles for specific services.
What is the out-of-pocket limit for this plan ?	Durable Medical Equipment (in-network only): You pay 20% up to \$500 per individual Prescription drug : \$1,325 Individual \$2,650 Family	If you have other family members in this plan , no one family member will contribute more than the individual amounts to the overall family out-of-pocket limit . The out-of-pocket limit is the most you could pay during a coverage period (usually one year) for your share of the cost of covered services. This limit helps you plan for health care expenses. The federal maximum out-of-pocket is \$12,000 individual/\$24,000 family. This applies to all essential health benefits, including some services not included in the out-of-pocket limit . (i.e. certain level 3 & 4 prescription drugs and adult hearing aids covered under this plan).
What is not included in the out-of-pocket limit ?	Copayments for Level 3 and Level 4 non-preferred specialty drugs . Coinsurance for adult hearing aids, premiums and health care this plan doesn't cover.	Even though you pay these expenses, they don't count toward the out-of-pocket limit .

Will you pay less if you use a network provider ?	Yes. See https://group-health.com/members/find-a-doctor or call 1-833-742-0952 for a list of network providers .	This plan uses a provider network . You will pay less if you use a provider in the plan's network . You will pay the most if you use an out-of-network provider , and you might receive a bill from a provider for the difference between the provider's charge and what your plan pays (balance billing). Be aware, your network provider might use an out-of-network provider for some services (such as lab work). Check with your provider before you get services
Do you need a referral to see a specialist ?	No	You can see the specialist you choose without a referral . However, it is recommended you get a referral to an orthopedist or neurosurgeon for low back pain
