Are there services covered before you meet your <a href="#">deductible</a> ?	No	This <a href="#">plan</a> covers some items and services even if you haven't yet met the <a href="#">deductible</a> amount. But a <a href="#">copayment</a> or <a href="#">coinsurance</a> may apply. The <a href="#">out-of-pocket limit</a> is the most you could pay during a coverage period (usually one year) for your share of the cost of covered services. This limit helps you plan for health care expenses. The federal <a href="#">maximum out-of-pocket</a> is \$9,450 individual/\$18,900 family. This applies to all essential health benefits, including some services not included in the <a href="#">out-of-pocket limit</a> .
