For Medicaid, the items will only be reimbursed if they have the appropriate diagnosis code that defines medical necessity otherwise they require medical necessity review through the prior authorization process.

COMMERCIAL

State of Wisconsin/Commercial Members: Two pair per benefit year are covered.

MEDICAID

Three pair per calendar year are covered.

Compression stockings purchased over the counter are not a covered benefit.
